
Profile Section - Socio-Demographic and Economic Factors

- Economic and Social Resources: partnerships, additional funding, in-kind resources, and resource development; and existing social resources – parks, tourism etc.
- Description of Service System: services in place, number of people served in each county, and category of populations (for example, mental illness, physical/developmental disabilities, and Alzheimer's)
- Role in Interagency Collaborative Efforts: advocacy role collaborations, partnerships, etc.

 - Crisis Communication Plan
- <u>We review, and update as needed, our related Policies and Procedures</u>: various scenarios
- <u>Staff and Manager on Duty receive training:</u> 2023 Annual training is completed
- <u>We complete drills throughout the year</u>: 1st drill for this season was done 6/7/2023
